

This document describes the privacy policy of savesophia.org (hereafter the "Website"). This document clarifies what types of information may be collected and stored on the Website and how this data may be used and provided.

Personal data collection and use

Personal data is information that relates to an identified or identifiable individual. The visitor may be asked to enter personal data to register on the Website. Darnitsa may store the information about the connection, traffic, date and the duration of the session on the Website. Collected personal data is used for information exchange, as well as for advertising and communication in accordance with the Laws of Ukraine "On Protection of Personal Data," "On Information", "On Advertising", "On Telecommunications", "On Entrepreneurship", "About information protection in information and telecommunication systems", ND TZI 2.5-010-03 "Requirements for protection of information of the WEB-page from unauthorized access." Personal data can be stored for 3 years. The Website records the domain name or IP address of the visitor's computer, access date, files (file name and URL), HTTP response code and the website from which the visitor came to the Website, as well as the number of bytes transferred during the session. The Website uses cookies to ensure security. Cookies also allow for tracking the violations of privacy policies and conditions of the use of the Website by visitors / their devices. Google Analytics collects stats about visits to the Website, including visited pages, pageviews, information downloaded, ISP domains and geography, as well as addresses of websites visited before and after the Website, etc. None of these actions are related to the visitor personally and are measured only as a whole.

- domain name, IP address with which you access the Website;
